## Audit Committee Structure, Responsibilities, and Member Introduction

## I. Committee Composition

To enhance corporate governance practices, the Company established the Audit Committee on June 14, 2017, in accordance with the Securities and Exchange Act, replacing the role of supervisors. The Committee operates in accordance with the Audit Committee Charter and is responsible for overseeing the following matters: the fairness of the Company's financial statements, the selection (or dismissal), independence, and performance of the certified public accountants, the effective implementation of internal controls, compliance with relevant laws and regulations, and control of existing or potential risks faced by the Company.

## II. Main Responsibilities of the Audit Committee

- 1. Review the fairness and accuracy of the Company's financial statements.
- 2. Select (or dismiss) the certifying CPA and evaluate their independence and performance.
- 3. Ensure effective implementation of the Company's internal control system.
- 4. Monitor the Company's compliance with applicable laws and regulations.
- 5. Oversee the control mechanisms for existing or potential risks faced by the Company.
